

# **FINESSE LIMOUSINE SERVICE**

## **CONTRACT / COMPANY RULES & REGULATIONS**

### **TCP- 9438**

1. No Smoking! It is renters responsibility to enforce NO SMOKING RULE!
2. The renter will be held responsible for all damages to the vehicle or its contents due to negligence intentional misconduct, malicious mischief or any other wrongful act, or threat of danger to the chauffeur and/or passengers. No wrestling or playful fighting or fighting in and around the vehicle.
3. There will be a \$100.00 cleaning charge if and when the limousine is left in an unfashionable manner. There will be a \$800.00 MINIMUM CHARGE for anybody that vomits in the limousine. The service will be terminated. The renter will be charged the full amount of the rental. If and when the chauffeur is asked he/she will pull over and stop when it is safe to do so.
4. It is imperative for the safety of the passenger(s) that no one shall stand or hang of the sunroof and/or windows while the vehicle is in motion. This is against the law and could result in a ticket payable by the rental. Seatbelts are provided, but not required.
5. THE LAW PROHIBITS MINORS (UNDER THE AGE OF 21) THE USE OF ALCOHOLIC BEVERAGES: Sections 5384.1 and 5384.5 of the public utilities code state NO ONE UNDER THE AGE OF 21 SHALL USE ALCOHOLIC BEVERAGES IN OR ABOUT THE VEHICLE. The chauffeur may ask for proper identification. IF THE LAW IS BROKEN THE SERVICE WILL BE TERMINATED. The customer will be return to pick up address. The renter will be charged the full agreed amount of the rental.
6. We are not responsible for articles left, damaged or stolen from the vehicle.
7. The company, its owner, or employees will not be held responsible or liable for any vehicle accidents, injuries, breakdowns, or any other unforeseen occurrences prior to or during any event that could cause delay or cancellation.
8. The company must be notified in advance of the number of people in the party and the destination with all the stops. Additional charge could occur due to additional stops and/or miles. Each vehicle is designed to carry a certain amount of passengers. The number of passengers will not exceed that amount. Example: 14 passengers means 14 passengers.
9. All charter rides are required to have a credit card on file. All payments shall be in cash, credit card, cashier check or money order. Additional charges will be automatically charged to the credit card.
10. If and when the rules are not followed it is at the discretion of the chauffeur to terminate the rental. The renter will be charged the full agreed amount of rental.
11. At the time of the reservation a credit card is required along with a non-refundable deposit.
